Hair and Makeup Services Agreement

By signing this agreement, I _____ fully understand and agree to the following terms and conditions of my hair and makeup services rendered from Clay Spann and his team of hair and makeup artists for the sole purpose of the 2019 International Pageants competition.

- There will be no refunds of any type given whatsoever for any reason.
- The booking of these services are on a first come, first serve basis. However, keep in mind that we rotate our clients who go earliest in the morning, so that the same clients aren't going early everyday.
- Photogenic by Clay Spann, LLC requires a 50% non-refundable deposit to book your services with the remaining 50% balance being due no less than 1 week prior to arriving in Charleston, WV for the pageant. If you are unable to compete in Charleston for any reason, you will not be refunded your deposit, unless approved by Photogenic by Clay Spann, LLC.
- We request that you pay by major credit card. We do not accept checks and recommend that you DO NOT mail loose cash, as we cannot guarantee it, if it were to get lost.
- We will ask to store your credit card information on site in a secure location to make for an easy transaction at final payment time, however you are not required to. If you choose not to, expect a phone call from someone at Photogenic by Clay Spann, LLC to handle the remaining balance no later than 1 week prior to arriving in Charleston.
- We ask that you be on time to your appointment. Preferably (10 minutes early.) If you are more than 15 minutes late, your stylist will move onto the next contestant as to not run behind the rest of contestants utilizing our services. If a stylist does not have enough time to get back to your services, those services will be void and you understand that by signing this agreement.
- You will not be allowed to leave rehearsals to return to the hotel if you are using our hair and makeup services. This makes it easy for you, and our team to perform your services to the fullest and highest quality possible without rushing you through the process. This also will help leave time right before show time to complete any touch ups if necessary.
- Each contestant is allotted 1.5 hours with her stylist for hair and makeup.
- Parents are not allowed in the hair and makeup areas. Your guardian can walk you to the hair and makeup room but must either remain outside in the hallway or leave. This helps us move quickly and efficiently without anyone in the room other than the stylists and contestants.

By signing this form, you give us permission to debit your account for the amount indicated on or after the indicated date. This is permission for a single purpose only, and does not provide authorization for any additional unrelated debits or credits to your account other than for The International Pageant services. You may have more than one transaction depending on the complexity of your booking and the number of payments made to satisfy the balance due. This form only authorizes us to charge your card accordingly.
